# ABSTRACTS DESIGN



## REQUIREMENTS FOR REPORTS ABSTRACTS

1. The scope of reports – up to 5 full pages, including figures, tables, and references. The design of the text, figures and tables must meet the generally accepted requirements for scientific publications design.
2. Technical parameters: text editor MS Word; font – Times New Roman; size – 14; line spacing – 1.5 cm.; paragraph – 1.0 cm.; upper, lower, left and right margins 2.0 cm.
3. Layout of figures and tables: figures and tables must be presented immediately after the text, where they are mentioned for the first time, or on the next page. Drawings must be grouped as a single object (scanned objects are not allowed). Design of figures and tables should be black and white, using Times New Roman font, size – 12; line spacing – 1.0. The source should be indicated under the tables and figures. Layout of tables in landscape format is not allowed.
4. Mathematical formulas should be executed in the Microsoft Equation formula editor.
5. References in the text must be placed in square brackets indicating the source and page number, for example: [1, p. 2]. Please, present the references taking into account the developed National Standard of Ukraine DSTU 8302:2015 “Information and documentation. Bibliographic references. General rules of composition”.
6. The transfer of words (including the automatic one) is not allowed.
